Fees listed are in addition to base monthly rent. Fees are subject to change and may vary based on screening results, lease terms, and other factors. Additional fees may apply in specific situations, as outlined in the application and/or lease agreement. Residents may also be responsible for applicable taxes, maintaining required insurances, activating/utilizing utility services per lease terms, and incidental damages. This guide is for informational purposes only and does not modify the lease. For full details, please refer to your lease agreement or contact the leasing office.

* All residents are required to acquire and retain a renter's insurance liability policy for the duration of their tenancy, and to provide proof of the initial policy and each renewal to the leasing team prior to move-in or expiration of a prior policy term. Should a resident fail to secure a compliant policy, or should they allow the policy to lapse at any point during tenancy, a recurring \$9.63/mo fee will apply until such time that proof of active renter's insurance is provided and verified.

** All residents are required to set up and maintain a billing account for the Electric Utility directly with the provider (Xcel Energy), for the duration of their tenancy. Should a resident fail to set up this utility to be directly billed in their name, set the billing to start on a date later than the lease-start date or end earlier than the lease-end date, or should they allow the utility to default back to the Property billing account at any point during tenancy, the billed usage will be charged through to the resident ledger for reimbursement by the tenant, along with a \$16.50 fee per bill that was processed and paid by the Property.
