## RESIDENTS RECYCLE RESPONSIBLY PROGRAM (R<sup>3</sup>P)

### Why Recycle? It is the Right Thing to Do!

But did you know that Fort Hood Recycle sponsors events like the fireworks for the 4th of July Independence Day celebration, UFC/Boxing Fight Nights, Oktoberfest, Month of the Military Child and other Soldier and Family events. Fort Hood Recycle gives back an average of \$100,000 annually to support these community events. But imagine, if everyone did their part to recycle right and recycle often, sponsorships could more than triple to \$300,000 to support more Family and Soldier initiatives and events!

The success of the Residents Recycle Responsibly Program (R<sup>3</sup>P) is contingent on keeping contaminants out of the blue recycle bin.

**Fort Hood Family Housing will provide one blue recycle container per family to collect recycle materials.**

Keep your recycling out of bags. Place items loose in the bin.

\*Shredded paper is the only exception to the no-plastic bag rule.

Items listed in the "No, Thanks!" section will contaminate acceptable recyclable materials and prevent the proper processing at Fort Hood Recycle. Tanglers, such as plastic bags, textiles, rope, hoses, wires, and cords will interfere with sorting equipment, requiring maintenance, which increases cost and jeopardizes worker safety.

### R<sup>3</sup>P Pledge

(Family Name), commit to recycle only acceptable materials such as cardboard, paper, plastics #1-2, and metal cans (see list above). We will only deposit acceptable and uncontaminated recyclable items.

#### We will not:

1. Bag recyclables.
2. Place solid waste in the blue bin.
3. Place hazardous items in the recycle bin.
4. Place animal waste or animal parts (Fort Hood fines up to \$2,000).
5. Place glass, diapers, needles, sharps, furniture, batteries, ammunition, etc. (see list).

We will do our part by setting the example, getting involved in the community, and incorporating green practices in our daily routine.

We will encourage all Family members to reuse, reduce, and keep a clean and beautiful Fort Hood community.

### Blue Recycle Bin Inspection:

The blue recycle bins will be inspected weekly at random by FHFH and Inland Services.

Containers containing unacceptable items will be tagged and be left unemptied.

Residents will be responsible for removing contaminants out of the blue recycle bins.

Failure to remove contaminants for more than two cycles (2 weeks) will revoke a resident's right to continue in R<sup>3</sup>P.

### Fort Hood Recycle Program:

Recycle's single stream program does NOT mean everything. The recycle program allows for only certain acceptable materials to be commingled. the recycle center is available for anyone living on or off post.

### Fort Hood Classification Unit:

Recycle household hazardous waste products and residential electronic waste at the Classification Unit. Acceptable items include used oil, antifreeze, transmission fluid, brake fluid, fuel additives, aerosol cans, cleaners, household batteries, pesticides, herbicides, paint, stains, varnish, light bulbs, fluorescent lights, computers, phones, game systems, printers, and other electronics (except CRT screen TVs and monitors).
