Renters insurance is required at time of move-in and must be maintained at all times during residency with Hickam Communities at the expense of the resident. Renters insurance protects you from claims for property damage and physical injury caused by or to you, a member of your family or a quest while living in your home.

The lease requires proof of insurance coverage meeting the minimum requirements with Hickam Communities named as an interested party at time of move-in.

Minimum Required Insurance Coverage:

· Limits of liability in an amount of at least \$100,000 per occurrence

Required Proof of Insurance –

one of the following must be provided to Hickam Communities prior to move-in:

- Declaration Sheet
- Certificate of Coverage
- Confirmation of Coverage letter from agent or insurance company
