Crustaceans	Hermit crabs, crawfish, shrimp

## Animal Restrictions

<b>Any dog (of any breed) that demonstrates a propensity for dominance or aggressive behavior as indicated by any of the following types of conduct:</b>	<ul style="list-style-type: none"> <li>• Unprovoked barking, growling or snarling at people approaching</li> <li>• Aggressively running along fence lines when people are present</li> <li>• Biting or scratching people</li> <li>• Escaping confinement or restriction to chase people</li> </ul>
Reptiles	Ex: Snake, lizard, turtle, tortoise, crocodile, alligator, iguana, komodo dragon, newt, gecko, gila monster
Arachnids	Ex. Spider, scorpion
Rodents	Ex. Mice, rat, gerbil, mole, beaver, squirrel, porcupine, chipmunk, prairie dog, groundhog, gopher, shrew, bat, hedgehog
Wild animals	Ex: Fisher cat, fox, weasel, raccoon, monkey
Exotic animals	Ex: Ferret, rabbit, chinchilla
Farm animals	Ex: Pig, horse, cow, chicken, sheep, goat
Birds of prey	Ex: Hawk, eagle, buzzard, vulture, owl, falcon, harrier, kite



\*Restricted breeds may not apply to service or companion animals.

Fort Drum Mountain Community Homes recognizes the importance of animals to residents. Animal ownership is a privilege that will be extended to all residents of our properties. Residents must request and obtain written approval before moving their animal into the premises including emotional support and service animals. An Animal Addendum must be completed, either at move-in or immediately upon acquiring a new animal. Residents are responsible for any animal in their care including those that may be temporarily in your care or those of guests visiting.

Residents must register any animal in their care for more than two (2) weeks.

**MICRO CHIPPING, VACCINATION(S), REGISTRATION & LICENSING:** Cats & Dogs are required to have vaccination(s) and be registered, licensed & micro chipped within forty five days of home acceptance as per local laws. The Veterinarian Services will provide a Verification of Pet Registration on Fort Drum.

Proof of vaccination, registration and micro chipping must be provided to the community office for each pet within 45 days. Failure to do so will result in a possible fine of \$150 missing registration and \$150 for missing vaccination and microchipping records. Records not received within 59 days result in the loss of pet privileges.

**RESTRICTIONS:** You are responsible for the animal's actions are all times. Please refer to the Resident Guide for a complete list of rules and guidelines. We reserve the right to change and update rules and guidelines.

- The animal must not disturb neighbors or other residents, regardless of whether the animal is inside or outside the dwelling. If Landlord, in its sole discretion, determines that the animal has significantly disturbed neighbors or other residents, it may require resident, upon written notice, to immediately and permanently remove the animal from the premises.
- Dogs, cats, companion animals and service animals must be housebroken. All other animals must be caged at all times. No animal offspring are allowed.
- The animal may not be tied to any fixed object anywhere outside the dwelling.
- All yards and common areas should be kept clean of animal droppings. Owners must pick-up and properly dispose of animal droppings immediately in common areas as well as one's own premises. This will eliminate health and sanitary concerns.
- Avoid leaving animal food outside for prolonged periods of time, as it will attract insects and wild animals. Your animal must be fed inside the dwelling unit.
- You must keep the animal on a leash and under your supervision when outside the dwelling unit or any private fenced area.
- Violation of Rules - Violation of the animal addendum and/or Resident Guide may result in fines, loss of animal privileges or eviction.
- Removal of Animals - Animal abuse or neglect will not be tolerated and may result in eviction. Any neglected or abused animal will be impounded by the proper authorities and sheltered during the investigation. Expenses associated with impounding are the responsibility of the owner. Reports of unprovoked bites, aggressive and nuisance behavior may be cause of removal of the animal.
