



Renters Insurance **REQUIRED**



Renters insurance is required at time of move-in and must be maintained at all times during residency with Cadence Communities at the expense of the resident. Renters insurance protects you from claims for property damage and physical injury caused by or to you, a member of your family or a guest while living in your home.

The lease requires proof of insurance coverage meeting the minimum requirements with Cadence Communities named as an interested party at time of move-in.

Minimum Required Insurance Coverage:

- Limits of liability in an amount of at least \$100,000 per occurrence

Required Proof of Insurance – one of the following must be provided to Cadence Communities prior to move-in:

- Declaration Sheet
- Certificate of Coverage
- Confirmation of Coverage letter from agent or insurance company

Liability Coverage

What if someone is injured at your rental home and you can't cover their medical bills? What if that person sued you, or your dog bit someone's child, or someone tripped and fell over a toy inside your home?

Your renters insurance policy must list the following as an interested party:
