## PURPOSE

The Resident Ambassadors Board's (RABs) objective is to improve the on-base living experience and satisfaction for all residents through volunteerism, listening to residents, and facilitating resident connection and communication. This document serves as an application to join the RAB.

## RAB VALUES

RAB Ambassadors adhere to the following core values:

- **Service** – We are the bridge between community needs, resident advocacy, and resident connection.
- **Open and Active Listening** – We prioritize empathy and create an environment where all voices are heard and respected.
- **Candor and Transparency** – We engage in open, honest communication, sharing information transparently between project leadership and residents.
- **Respect** – We treat all individuals with dignity, regardless of their background, position, or opinions, and value their unique contributions.
- **Inclusivity** – We provide an opportunity for all voices to be heard and all residents to be represented.
- **Exemplary Conduct** – We model exemplary behavior in all our interactions with residents, fellow RAB Ambassadors, project teams, vendors, stakeholders, and all people we encounter.
- **Follow-Up** – We complete tasks within agreed-upon timelines and keep residents informed of RAB actions and activities.

## AMBASSADOR QUALIFICATIONS

### Eligibility Requirements

- A current resident of the community in good standing.
- The lessee or spouse of the lessee.
- At least 18 years of age.
- Not employed by Centinel, Winn, or any subcontractor affiliated with the community.
- Must not have any conflict of interest, including but not limited to:
  - Active participation in external advocacy groups.
  - Roles on-base that influence or oversee housing operations.
  - History of significant negative interactions with residents or housing staff.
  - Ties to vendors or potential nepotism concerns.

- Ambassadors must commit to a minimum one-year term.
- Attend all Regular RAB Meetings (held every 60–90 days), with one excused absence per calendar year.
- Participate in Community Conversations Forums.
- Volunteer at a minimum of three RAB-sponsored or community events annually.
- Join Volunteer Committee Team Meetings as needed for planning and coordination.
