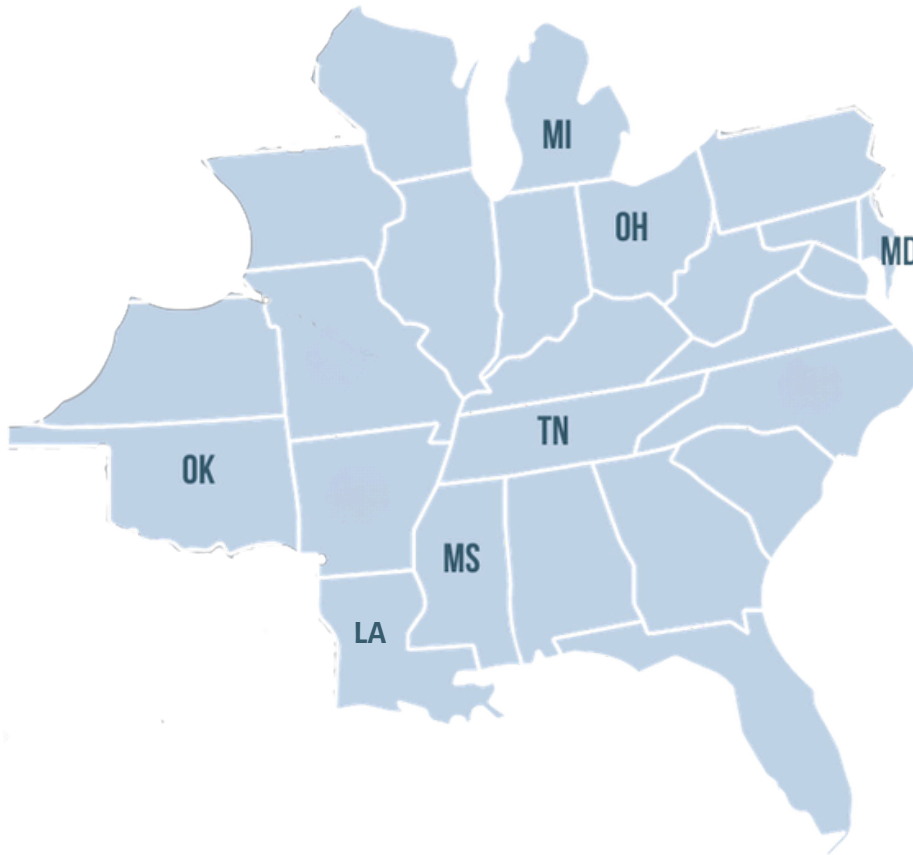


PORTFOLIO
