# **Privacy Policy**

# 1. Introduction and Your Acceptance

This privacy policy tells you about the personally identifiable information that Lake Pointe Village Apartments ("we," "us" or "our") collects through the operation of our website located at <a href="https://www.lakepointevillagetc.com">https://www.lakepointevillagetc.com</a> and how we may collect, use, disclose, and protect this information in compliance with federal and state laws. ### 2. Information We Collect

We collect personal information you voluntarily provide, including, but not limited to:

- Identity Information: Full name, date of birth, Social Security number, driver's license/state ID number, passport number;
- Contact Information: Current and previous addresses, phone numbers, and email addresses;
- Employment and Income Information: Employer name, income verification, tax documents, pay stubs, and employment history;
- Emergency Contact Information: Name and contact details of individuals to reach in case of an emergency;
- Tenant History: Rental history, landlord references, and eviction records;
- Credit Information: Credit reports and credit scores obtained from consumer reporting agencies with your consent;
- Background Checks: Criminal history, eviction records, and identity verification reports.

### 3. How We Use Your Information

We use your information for legitimate business purposes, including, but not limited to:

# A. Rental Application, Property, and Lease Management

- Processing rental applications and screening tenants;
- Preparing and managing lease agreements;
- Collecting rent payments and managing accounts;
- Communicating with you regarding maintenance, emergencies, notices, updates, and enforcing lease terms and community policies.

# **B. Legal and Regulatory Compliance**

- Complying with fair housing laws, tax laws, and legal obligations;
- Responding to lawful requests by public authorities, including law enforcement.

#### 4. How We Share Your Information

We do not sell your personal information. However, we may share your information with:

### A. Service Providers

- Maintenance contractors, and utility providers;
- Payment processors for handling rent and fees;
- Background screening companies (with your consent).

# **B.** Legal and Regulatory Authorities

- Law enforcement agencies, courts, and regulators as required by law;
- In response to subpoenas, court orders, or legal processes.

#### C. Business Transfers

 In the event of a merger, sale, or transfer of assets, your data may be transferred to the new property owner or management company.

# **D. Emergency Situations**

Emergency contacts or first responders in case of health or safety incidents.

### 5. Data Retention

We retain your information for as long as necessary to fulfill the purposes outlined in this Privacy Policy, comply with legal, tax, or regulatory requirements, and to enforce lease agreements and resolve disputes.

# 6. Your Privacy Rights

Under Michigan and federal laws, you have the right to request copies of the personal information we hold about you, request corrections to inaccurate or incomplete information, request deletion of your data when it is no longer necessary for business or legal reasons, and/or decline marketing communications by following opt-out instructions in emails or contacting us via the methods listed below.

### 7. Use of Cookies and Tracking Technologies

Our website uses cookies and similar technologies to enhance your browsing experience, analyze website traffic and usage, and offer personalized content and advertisements.

Cookies, for example, are alphanumeric identifiers that we transfer to your computer's hard drive through your web browser. They make it possible for us to recognize your browser when you visit and provide you with information about products that interest you.
