

OFFICIAL RULES FOR "TOUR FOR A CHANCE TO WIN 2 DREAMVILLE FEST TICKETS" SWEEPSTAKES. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

- 1. ELIGIBILITY: In order to be eligible to participate in the "TOUR FOR A CHANCE TO WIN 2 DREAMVILLE FEST TICKETS" ("Sweepstakes"), each entrant must be 18 years of age or older as of the start date, and a legal resident of the United States. Proof of eligibility will be required. Prizes may be issues in the form of a gift card or other type of credit voucher at solely Sponsor's discretion, with store or brand of issuance varying by location of the Property where the winning entry was submitted.
