

## OFFICIAL RULES FOR "CAVALIERS MEET PALOMA KENT" SWEEPSTAKES. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

- 1. ELIGIBILITY: In order to be eligible to participate in the "CAVALIERS MEET PALOMA KENT" ("Sweepstakes"), each entrant must be 18 years of age or older as of the start date, and a legal resident of the United States. Proof of eligibility will be required. - 7. TERMS AND CONDITIONS OF AWARDING PRIZE: If Winner does not meet any of the eligibility requirements given herein, then a new Winner will be selected in another random drawing.
