

Protecting your private information is our priority. This Statement of Privacy applies to <https://fergusonandbrewer.com>, and Ferguson & Brewer Investment Company and governs data collection and usage. The Ferguson & Brewer Investment Company website is a property management site for rental housing and property. By using the Ferguson & Brewer Investment Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Ferguson & Brewer Investment Company may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

Use of your Personal Information

Sharing Information with Third Parties

Ferguson & Brewer Investment Company does not sell, rent or lease its customer lists to third parties.

Ferguson & Brewer Investment Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries.
